

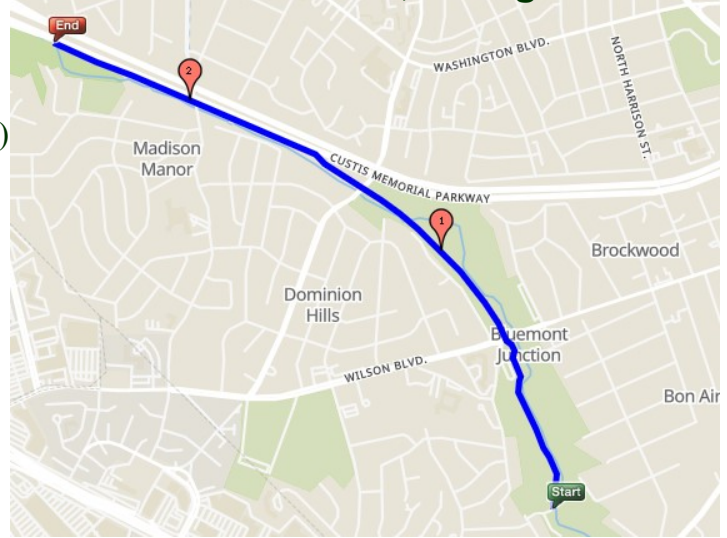


Potomac Valley Track Club Easter Classic 5K and 10K Saturday, March 30, 2024 5K at 8:00 AM – 10K at 8:10 AM

On-line at www.pvtc.org or mail after March 16: \$20 (members) \$20 (non-members)

- **Directions:** From Route 50, turn north to end of Manchester Street. Turn right onto free parking
